**Background to the BOPF Nature Together Project Worker post**

The Bristol Older People's Forum (BOPF) was formed in 1993. It has nearly 3,000 members and supporters and provides a range of services, as well as representing its members across the public sphere.

The BOPF Nature Together Project is a two-year funded programme designed to address nature decline. It builds on the launch of our [Community Climate Action Plan in June 2025.](#)

At the heart of the project is a strong commitment to ensuring older people are actively involved in its design and development. Working alongside the BOPF staff team and a core group of older adults, the project will focus on local, nature-based activities, intergenerational work, and meaningful connections with older people across Bristol.

**Job Overview:**

The Nature Together Project Worker will join the Bristol Older People's Forum (BOPF) team to deliver a two-year funded project addressing nature decline in Bristol. The role focuses on empowering older people to take an active role in local nature initiatives and engage in public discussions around nature and climate.

Using a community development approach, the postholder will ensure older people's voices are central to shaping solutions, while fostering intergenerational engagement and connecting local initiatives to broader environmental policy.

**Key Responsibilities:**

- Develop and support nature-based activities and projects with the Nature Together group of older people.
- Plan, facilitate, and deliver co-design workshops, meetings, and activities to ensure older people influence project outcomes.
- Promote nature initiatives through clear and accessible communication, including the BOPF website, social media, newsletters, and in-person engagement.
- Encourage and support older people to act as champions for wildlife and nature by engaging with local parks, gardening groups, community spaces, and nature organisations.
- Build and support collaborative relationships with agencies, community networks, voluntary sector partners, and local authorities.
- Design and deliver intergenerational activities, highlighting the value of collaboration between younger and older people.
- Recognise, understand, and challenge ageism and age discrimination, ensuring inclusivity and respect for diversity (age, gender, income, disability, ethnicity, sexuality).

- Support participants to link local nature projects to wider climate and environmental issues, including policy and advocacy opportunities.
- Contribute to project planning, monitoring, evaluation, and reporting. Ensuring learning is captured and shared.
- Ensure that the project targets agreed with the funder are met.

<b>5</b>	Experience working collaboratively with <b>agencies, community organisations, and local authorities</b> .
<b>6</b>	Competence in using <b>IT and digital communication tools</b> , including websites and social media.
<b>7</b>	Understanding of <b>ageism</b> and a commitment to <b>equity, diversity, and inclusion</b> across all protected characteristics.
<b>8</b>	Ability to <b>plan projects, draft reports, and carry out evaluations</b> .
